RELEASE OF LIABILITY, WAIVER OF CLAIMS, ASSUMPTION OF RISKS AND IDEMUNITY AGREEMENT

**BY SIGNING THIS DOCUMENT, YOU WILL WAIVE CERTAIN LEGAL
RIGHTS, INCLUDING THE RIGHT TO SUE. PLEASE READ CAREFULLY!!**

All United Rottweiler Klub of America, Inc. (URKA) events are held under the rules and policies of URKA. Absolutely no alcoholic beverages, illegal drugs or firearms will be allowed on the grounds or in the buildings on the day of a URKA sanctioned event. URKA, its board of directors, officers, volunteers, agents and employees, and the event host assume no responsibility for any loss, damage, or injury sustained by spectators or by exhibitors and handlers, or to any of their dogs or property, and further assume no responsibility for injury to children. URKA and the host club are not responsible for loss, accidents, or theft.

In consideration for allowing me to participate in any or all events and related activities of URKA, I hereby warrant and agree that:

1. I have read and understand URKA's Policies and Procedures of Misconduct of Members and Non-Members and I will abide by them regardless of whether I am a member of URKA. I have read and agree to comply with the URKA's Policies and Procedures of Misconduct of Members and Non-Members Section 2 Procedures for Discipline, and Section 3 Guidelines for Discipline including the fines and/or suspensions listed in that Section; and
2. I agree to comply with all rules posted at a URKA event or URKA sanctioned event, regardless of whether or not, I am a member of URKA; and
3. I am familiar with and accept that there is always the risk of serious injury and death resulting from participation in any organized recreational activity including the demonstrations, competition and like activities offered as part of the program of the United Rottweiler Klub of America Inc; and
4. I have satisfied myself, and believe, that I am physically, emotionally, and mentally able to participate in this program, and that my equipment is appropriate for use in this program; and
5. I understand that all applicable rules for participation must be followed and that at all times the sole responsibility for my dog's safety, and personal safety remains with me; and
6. I will immediately remove myself from participation, and **notify the nearest official**, if at any time I sense or observe any unusual hazard or unsafe condition or if I experience any deterioration in my physical, emotional or mental fitness, or that of my equipment, or exceed my comfort level, for continued participation in any event or related activity.

I UNDERSTAND AND AGREE, ON BEHALF OF MYSELF, MY HEIRS, ASSIGNS,

1. **WAIVER AND RELEASE:** I hereby release, waive, discharge and covenant not to sue URKA, its directors, officers, volunteers, employees and agents, and the event host from any and all liability to me, for all losses, injury, death or damage, and any claims or demands thereto, on account of injury to my person or property, or resulting in my death in reference to my attendance at any URKA event even if arising from the negligence or gross negligence of URKA or event host or event organizer.

2. **INDEMNIFICATION:** I hereby covenant and agree to indemnify and save harmless, URKA, its directors, officers, employees and agents, volunteers, and event host from any and all claims and demands, for all loss, injury, death or damage, that any person or entity may have or make, in any manner, arising out of any occurrence related to my actions or the actions of any of my guests or children.

3. **ASSUMPTION OF RISK.** I understand that my attendance at a URKA event may include activities that may be hazardous. I assume the risk of injury or harm in those activities I choose to do and release URKA from all liability for injury, illness, death, or property damage while attending a URKA event.

- b. I agree to indemnify and hold harmless URKA from any claims, causes of action, damages and/or liabilities, arising out of or resulting from my child's attendance at a URKA event. I further agree to accept full responsibility for any and all expenses, including medical expenses that may derive from any injuries to my child that may occur during his/her participation in the activities.
- c. I also agree to indemnify URKA and its directors, employees, volunteers, agents and event hosts from any financial obligations or liabilities that my child may cause while participating in the activities, including attorney's fees and court costs resulting from his/her misconduct, errors, or omissions.

I HAVE READ AND UNDERSTAND THIS AGREEMENT AND I AM AWARE THAT BY SIGNING THIS AGREEMENT THAT I AM WAIVING CERTAIN SUBSTANTIAL LEGAL RIGHTS WHICH I AND MY HEIRS, NEXT OF KIN, EXECUTORS, ADMINISTRATORS AND ASSIGNS MAY HAVE AGAINST THE RELEASEES.
